Dear Superintendents & Board Members:

We are writing to express our collective support for the unified funding formula approved by the Act 467 Committee on February 24, 2016. Together, our schools represent **90% of the New Orleans public schools** affected by this formula, across both RSD and OPSB.

We believe this formula appropriately prioritizes scarce resources for the most vulnerable children in our city – including special education students, English language learners, and overaged students. This formula still provides appropriate resources for gifted & talented students.

As you know, there are significant differences in the proportions of "at risk" students served across New Orleans public schools. It is important for our funding formula to account for these differences, ensuring that schools with above-average populations of high needs students receive the additional resources required to serve those children.

The formula approved by the committee does exactly that, and we are hopeful that the Board of Elementary & Secondary Education (BESE) will approve the new city-wide formula at its meetings next week.

Thank you for your partnership as we all work together to provide an excellent education to every child in New Orleans.
